WITH RECORD NUMBERS of military flights near Taiwan over the last week, China has been showing a new intensity and military sophistication as it steps up its harassment of the island it claims as its own and assert is its erritorial ambitions in the region.

HUNDREDS OF AFGHANS flocked to the passport office in Kabul on Wednesday, just a day after news that it would re-open this week to issue the documents, while Tailbans security men had to beat back some in the crowd in efforts to maintain order.

Tailban officials have said the service well resume from Saturday, after being uspended since their takeover and the fall of the previous government in August, which stranded many of those desperate to flee the country.

"I have come to get a passport but, as you can see here, there net lost of problems, the systemis not working" one applicant, Mabir Rasooli, told Resulters outside the office.

"There is no official to answer our questions here to tell us when to come people are confused! A spokesman for the Tailban officials running the passport department did not immediately respond to request for comment. Boverty and hunger have worsened since the Islamist movement took over Afghanistan, which already suffered from drought and the CW64-19 pandemic.

belong to the same ruling elite that is being blamed for the collapse and for derailing the lives of ordinary Lebanese who have lost ac-

Lebanese who have lost ac-cess to savings and now struggle to get fuel, electric-ity and medicine.

Bold-faced names in the leaked documents include the longtime central bank governor, a pivotal figure in the failed policies that helped trigger the financial crisis, as well as Prime Minis-ter Najib Mikati and his pre-decessor.

The documents, named the "Pandora Papers," were examined by the Interna-tional Consortium of Inves-tigative Journalists, with the first findings released Sun-day. The ICIJ report exposes the offshore secrets of wealthy elites from more than 200 countries and ter-ritories.
