Implementing Agency: International Foundation for Research & Education – Ashoka University

- UTI AMC has previously sponsored the entire graduation journey for 31 undergraduate students through the UTI AMC Scholarship from the academic year 2019-20 to 2021-22.
- In line with the good results, we sponsored another 18 students 10 third year undergraduates and 8 Young India Fellows with the UTI AMC Scholarship. About 75% of these students are now in their first jobs and the rest decided to pursue higher education.
- During FY 22-23, it was decided to sponsor the graduation journey for 9 first year undergraduate students through a 65% tuition waiver under UTI AMC Scholarship while also contributing to the operational expenses of the expanding campus of the University.

Implementing Agency: Gramin Vikas Vigyan Samiti (GRAVIS)

- This project, sponsored by UTI, serves 15 villages in the Jaisalmer and Sankra block of Jaisalmer (a NITI Aayog Aspirational District) by implementing water harvesting techniques and farming interventions coupled with building community learning and capacity building.
- GRAVIS has helped these villages with construction of water storage units for domestic consumption as well as farming needs and provided training to the people in the villages on how to optimize the resources available in the harsh weather conditions of their home location.
- GRAVIS also organizes outreach medical camps and awareness sessions for the ~30,000 people residing in these villages.

- TAF has created a model for high performing schools through 'The School Project' working in collaboration with the Municipal Corporations in Mumbai, Pune, and Nagpur to create a scalable school model within the government system that drives wider systematic reforms in education.
- UTI has been associated with The School Project since 2015 supporting their Wadibunder Mumbai Public School in Mazgaon and Natwar Nagar Mumbai Public School in Jogeshwari, Mumbai.
- During FY 22-23, we have extended financial support to Natwar Nagar Mumbai Public School for classes KG to Grade 9 with approximately 396 students.

Implementing Agency: Institute for the Handicapped & Backward People (IHBP)

- Founded by a Divyangjan himself, IHBP is a Kolkata based not-for-profit organization working for the upliftment and development of the marginalized and vulnerable sections of the society in West Bengal for over two decades.
- The Special School for the children with disabilities provides the students with a holistic education to enable them to lead a life where they are more self-dependent and can easily assimilate in the wider society.
- This a non-residential school with 225 students differently abled children suffering from various disabilities including hearing impairment, cerebral palsy, autism and mental disorders.

- Working at Ummeed is a transdisciplinary team of about 100 professionals such as developmental pediatricians, occupational therapists, mental health professionals, autism intervention specialists, special educators, speech therapists and social workers.
- Each year about 1200 children receive direct services at Ummeed through ~8000 sessions including home visits by the team. Concessional clinical services are offered to children and families from low/mid socio-economic backgrounds based on a sliding scale of family income.
- UTI has been sponsoring the clinical sessions for the children with developmental disabilities since 2020 and has till date sponsored over 4500 sessions for about 700 children.

- To extend the benefits of robotic surgeries to all poor patients requiring surgeries for uro-oncological conditions, cancers and kidney failures, the Robotic Surgical Unit was established at the Safdarjung Hospital, New Delhi – the largest hospital under the Ministry of Health & Family Welfare, Gol.
- To make procurement process leaner and reduce the time for procurement of consumables from 6-9 months to 2 months so as to ensure that the at-risk patients are timely operated, UTI procured the consumables for the robotic surgeries for about 100 patients at the Urology Department of Safdarjung Hospital.

- A 121 year old institution, Victoria Memorial School for the Blind is recognized as a specialized institution for education of children with visual impairment. A residential school with a capacity for 100 students, it provides free education, nutrition, accommodation, sports facility, skill trainings, and career guidance to its students.
- Over the last five years, UTI has been associated with the organization to sponsor the holistic education, lodging & boarding of the students at the school. This year, we supported half the student body of the school under our CSR initiatives.

- UTI has partnered with the RCME to provide 150 visually challenged individuals with a Smart Vision assistive wearable device that would help them to be more self-dependent.
- The device uses Artificial Intelligence, Machine Learning, Machine Vision and Internet of Things to help the wearer recognize objects, faces & expressions, and also their surroundings with the help of any smart phone.
- The device can help the wearer read, navigate with directions, identify objects and facilitate their dayto-day life.
