सध्या साधारणपणे दिवसभरात मुंबईला ५०, गुजरात १३ आणि दिल्लीला दोन वाहने पाठवली जातात. कांदा घेऊन मालाड. भिवंडी आणि गुजरातमध्ये वाहने लॉकडाऊनमध्ये जातात. भाजीपाला विक्री होईल की नाही. याबद्दल साशंकता असल्याने अनेक व्यापारी लिलावात सहभागी होत नसल्याचे बाजार समितीचे म्हणणे आहे. व्यापारी कमी असल्याने स्पर्धा होत नाही. किषमालास कमी भाव मिळण्याचे ते कारण आहे. कोरोनामळे बाजार समितीच्या आवारातील किरकोळ विक्री बंद करण्यात आली आहे.
